Bob Brown who leads the monthly COMPUTER CLINIC SIG has an interesting topic planned for August 22 at 10:00 a.m. The subject is Computer Security, concentrating on passwords and Flash Cookies. Everyone will benefit by attending this session.

Come and check this one out. Bob's is the only CKCS SIG that offers coffee and snacks – another perk for attending.

SOME NEW COURSES HIGHLIGHT FALL CLASS SCHEDULE

The CKCS class schedule starting in late September will have three new offerings that we have not taught before - Advanced Photoshop Elements, Windows Movie Maker and Google Docs. Plus we will offer several of our old standards such as Computer Basics, Beyond Basics, Microsoft Word, Macintosh OS X and five different courses on graphics and imaging.

Advanced Photoshop Elements will cover more tools available in Photoshop Elements 6. Such tools as Background Eraser, Levels and Color Replacement will be used to modify digital photos. Borders, Frames and other Effects will also be used. Introduction to Photoshop Elements is a prerequisite.

Windows Movie Maker is a video creating and editing tool contained in Microsoft Windows. This course will demonstrate how to create a dynamic TV presentation from photos and videos and then save it on DVD. Some features of the course include music backgrounds, pan and zoom transitions, titles and credits, video importing, editing and much more.

The Google Docs class will be an introduction to the office software product provided on the Internet by Google. The class is designed to show the alternative to Microsoft Office and other office software products. Google Docs offers word processing, spreadsheet, presentation and forms applications. The class will demonstrate how to use this free product and how to collaborate with others in the creation of online documents. Students must able to use the Internet and should have some experience with office software such as word processing.

We will also offer Computer Graphics, Introduction to Photoshop Elements, Beginning Digital Imaging, Advanced Imaging and Digital Independent Work. See the CKCS web site at www.ckcs.org for further descriptions and the most recent calendar.

All classes are scheduled to begin between September 21 and 26 and will complete by the end of October. Students may bring their own laptops if they have the course software installed.

NEXT VERSION OF MICROSOFT WORD IS 2010

Some of us may just now be getting comfortable with Word 2007, but already, Microsoft is working on their next release set for 2010. Word, which is also available as a part of the Office Suite 2010 is expected to be released in the early part of next year. Actually, Word and the Office Suite is being offered to a select group of testers at this time.

The new version of Word is expected to include such changes as an improved copy and paste system, a new 'smart art' system. a 3-D effect or glow effect for headings, a new document map with a remarkable new search feature which works in real time. With the release scheduled for 2010, this means that Microsoft is becoming consistent with a new release of their operating systems and Office Products about every three years. Their newest operating system, Windows 7, is due to be released on October 22, if 2009. This is three years after their release of the Windows Vista.

"THE INTERNET: THE MOST POWERFUL ENGINE OF MISINFORMATION"

That heading is a quote I read somewhere recently, I don't remember but I think it was in an issue of Newsweek. In my mind that statement is right on the mark!

If you have attended any of my Word Processing SIGS recently, I am confident you have heard me say that I believe at least 75 to 80% of the stuff that is on the Internet is not true. It is amazing to me that some people will continue to forward derogatory comments about a person, a group, a place or thing, which is not true. Some things that get forwarded convey ideas and thoughts that are not logical – ideas that even the most illogical mind would question.

I once confronted a Tennessee friend of mine, who forwarded a very derogatory story about a political figure that he did not like. The story was not logical, so I went to www.truthorfiction.com which clarified that the story was not true. I forwarded that to my friend, and his response was "that's OK, the story is too good not to forward." I learned that he continued to circulate the story even though he knew it was a lie. What a friend!



In the days following Walter Cronkite's death last month, there were dozens of documentaries about his life and things he

accomplished. CNN replayed an interview Larry King (CNN Larry King Live) did with Walter Cronkite. They talked about the sources of news, and Cronkite discuss the point and time that television news really came into prominence (President Kennedy's assassination). (I did not record the Larry King interview so I paraphrase his comments.) [He commented that the Internet is becoming a major source of news and even many newspapers now were switching their editions to be viewed online. In time, he said, most newspapers will be published only online. The Internet has allowed lots of citizens to become reporters of the news. Cronkite said that such purveyors of news should be responsible about what they report. He used the word responsible several times and said that the rules of liability, which applies to newspapers, should also apply to those who post stories on the Internet.] Things would surely change if one could be sued for creating or forwarding false information and knowing it was false.

My philosophy is; one shouldn't forward stories or information as fact unless you know it is factual. Some people will write an interesting story attributing them to celebrities such as Andy Rooney, George Carlin, etc. I'm sure you have seen those too. In most cases, a check of those stories will tell you they weren't written by the celebrity. In such a case, I do not forward such stories.

I am always glad to receive a funny story, a video, a joke or some beautiful pictures. If you are like me – that is the only thing I want to see anyway.

Before I forward anything that looks the least bit questionable, (i.e. coughing can save you during a



"FORWARD THIS TO TEN FRIENDS OR YOU WILL HAVE BAD LUCK"

By now, I suspect everyone is familiar with www.snopes.com and/or www.truthorfiction.com for determining whether information received via email is just that: true/false or fact/fiction. Both are excellent sites. Below is the advice from one of those two services.

Advice from Snopes.com

- 1) Any time you see an E-Mail that says forward this on to '10' of your friends, sign this petition, or you'll get bad luck, good luck, or whatever, it almost always has an E-Mail tracker program attached that tracks the cookies and E-Mails of those folks you forward to The host sender is getting a copy each time it gets forwarded and then is able to get lists of 'active' E-Mails addresses to use in SPAM E-Mails, or sell to other spammers.
- 2) Almost all E-Mails that ask you to add your name and forward on to others are similar to that mass letter years ago that asked people to send business cards to the little kid in Florida who wanted to break the Guinness Book of Records for the most cards. All it was, and all any of this type of E-Mail is, a way to get names and 'cookie' tracking information for telemarketers and spammers to validate active E-Mail accounts for their own profitable purposes.

You can do your friends and family members a GREAT favor by sending this information to them; you will be providing a service to your friends, and will be rewarded by not getting thousands of spam E-Mails in the future!

If you have been sending out (FORWARDING) the above kinds of E-Mail, now you know why you get so much SPAM!

Do yourself a favor and STOP adding your name(s) to those types of listings regardless how inviting they might sound!

You may think you are supporting a GREAT cause, but you are NOT in the long run. Instead, you will be getting tons of junk mail later! Plus, we are helping the spammers get rich! Let's don't make it easy for them!

Also: E-Mail petitions are NOT acceptable to Congress or any other organization. To be acceptable, petitions must have a signed signature and full address of the person signing the petition.

FREE 411 INFORMATION

Do you remember when you needed to call the local telephone company for information to request that they look up a phone number? I still remember having to pay \$1.50 for such a service which was added to my monthly phone bill. Then if you wanted them to dial the number for you, there was an additional charge. The situation is worse now-a-days because there are so many phone books and none of them seem to be complete.

Just leave it to the folks at Google to develop and offer you a free 411 information service.

Here's a number worth putting in your home phone speed dial or in your cell phone memory.

1-800-goog411

This is an awesome service from Google, and yes, it's free. It's great when you are on the road. Don't waste your money on information calls and don't waste your time finding and manually dialing the number.

I am driving along in my car and I need to call the golf course and I don't know the number. I hit the speed dial for information that I have programmed. The voice at the other end says, "City & State." I say, "Garland, Texas." He says, "Business Name or Type of Service." I say, "Firewheel Golf Course." He says, "Connecting" and Firewheel answers the phone. How great is that? This is nationwide and it is absolutely free!

For those of you who subscribe to AT&T cell phone service, the Google service can be used, but on your ATT phone, all you need to do is dial 411 and the procedure is the same as described for

Google. AT&T will also offer you the street address if you request. The last time I used that service, when I finished, it automatically sent me a text message with the phone, business name, street address and zip code - see the copied text message at left. If you don't hang up, but wait a few seconds, they will also dial the number for you. Should the line happen to be busy or later you needed to call that number, you may go to the text message, click on the phone number and AT&T will again dial for you. Yes, this is also a free service, however any charges that are customary for text messages or minutes will

apply. You may turn off the automatic text message if you so desire.

Other cell phone companies may also offer this or a similar service. You should contact your cell phone company for more information.



APPLE'S NEXT OPERATING SYSTEM: SNOW LEOPARD

What: Snow Leopard (also called Mac OS 10.6)

When: Goes on sale in September 2009

Snow Leopard required processor: Intel-based Mac, won't work with older

Macs that have a PowerPC processor

Cost: \$29 for Mac users upgrading from Leopard; \$49 for a Family Pack which upgrades five Macs running Leopard to Snow Leopard; for Tiger users. Apple is offering a Mac Box Set. It will cost \$169 (\$229 for Family Pack to upgrade a maximum of five Macs). Mac Box Set includes Snow Leopard, iWork '09 and iLife '09.

Benefit: Apple says Snow Leopard will improve your Mac's performance and increase the power of the operating system. Nearly all system applications are rewritten in 64-bit code.

When Apple's newest operating system goes on sale this fall, it will not be a radically new piece of software. Instead, Apple says it will be a refined version of the current OS called Leopard. In Apple's terms, Snow Leopard will be "refined, not reinvented." Look for your Mac to wake up and shut down faster, and to join wireless networks faster. In fact, Apple claims that Snow Leopard will shut down up to 75 percent faster than Leopard, and join wireless networks up to 55 percent faster.

Apple could market Snow Leopard as the most svelte operating system on the market. The company says Snow Leopard will take up less than half the disk space of Leopard, freeing up about six gigabytes (GB) for the average Mac user.

Look for other improvements including better disk eject reliability, more efficient file sharing, better text selection in PDFs, automatic updates for printer drivers, automatic time zone setup, and faster, more reliable installation of the operating system.

TOP PASSWORD TIPS

How many of you regularly change your passwords and then log them in a notebook at home so you don't forget? Probably not that many of us. But it's a sound idea. Another smart tip is to create stronger passwords initially. I began thinking about password protection in mid-July when I stayed at a Kentucky motel offering five open wireless Internet networks. You might be asking, "what's wrong with that?" Sure, it's much easier to connect to a network when no passwords are required.

At the same time, I kept on thinking that anyone could be sitting in the parking lot "sniffing" the Internet activity on dozens of laptops being used by customers at that motel. Talk about insecurity.

By password protecting the networks with a strong WPA key, at least the motel gives a nod to the fact that it cares about who's on its network.

GOOGLE DOCS

I am writing this column on an iMac using Google Docs, which I'll be teaching at CKCS in the fall. Google Docs offers a free online word processor, spreadsheet, and presentation program. If you'd like to read a good book about Docs, check out the Missing Manual's Google Apps by Nancy Conner. It's available at the Lexington Library and helps get the reader up to speed with Google's Docs. (You might be asking what's the difference between Google Apps and Docs? Apps also includes Gmail, the popular Google email system, and Google Calendar, the online calendar which can be viewed and edited by multiple users on the Internet.)

If you'd like to read an interesting take on Google Docs, check out Nate Lanxon's column at the British version of clnet. Lanxon writes that every column he's written for clnet since Nov. 13, 2006 has been written using Google Docs. DVORAK'S SON BUYS A MAC

One of America's favorite computer columnists recently wrote: "It was a somber day for the Dvorak family recently when my son switched to the Mac..."

John Dvorak, writer for PCMag.com, informed his readers that his son bought a new MacBook Pro, "one of the few laptops being sold that actually impresses me." He added that he still uses an old desktop Windows machine and hasn't converted to full-time laptop use as many have. Dvorak says his son followed "the advice of pundits, technology writers, and everyone who ever gave advice about what to buy and why: 'Buy solutions, not hardware.' "

Dvorak's son bought the MacBook Pro to utilize Mac-only DEVONthink software, which Dvorak calls (Continue on next page)

stunning." The software organizes PDFs and then sorts them into database blocks. Dvorak's son is: writing a book and finds the software invaluable to complete the job.

Dvorak blasts Apple's retail stores but admits, "If I was going to buy a machine this minute, (the MacBook Pro) would probably be what I'd get too." He closes his column by remarking that Macs have clearly moved ahead of Windows machines in general usefulness.
